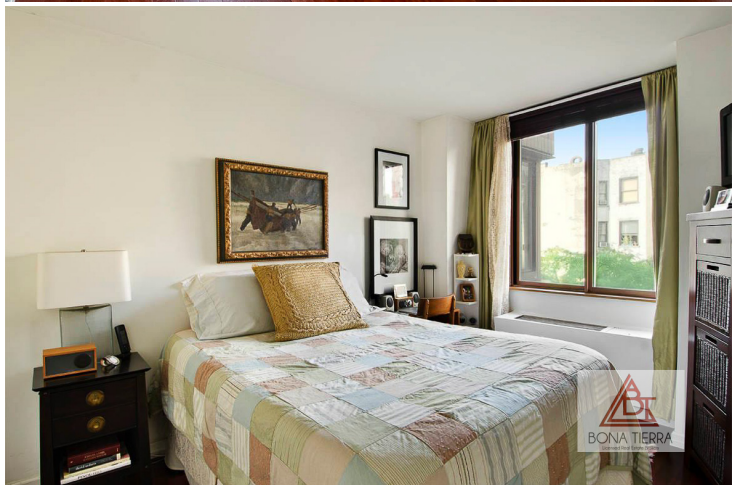
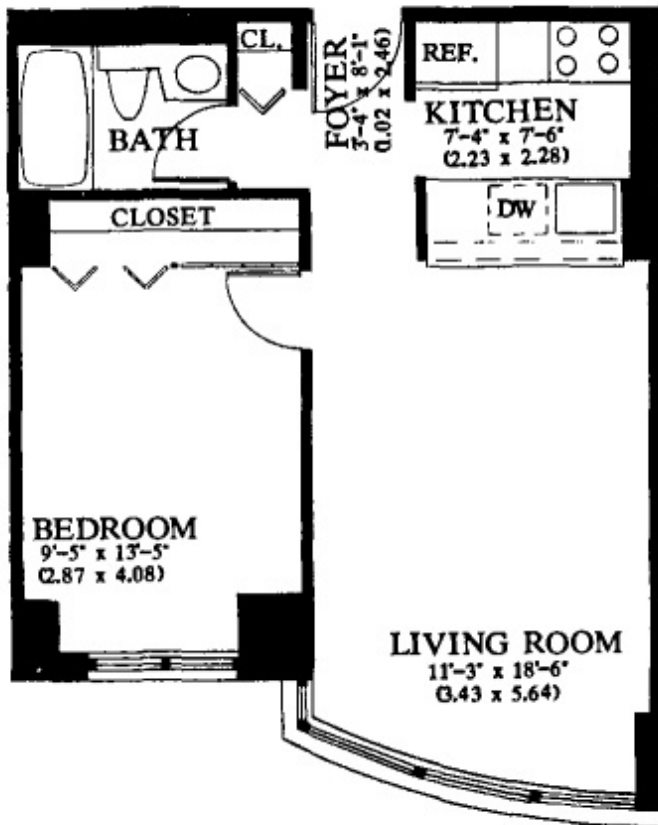

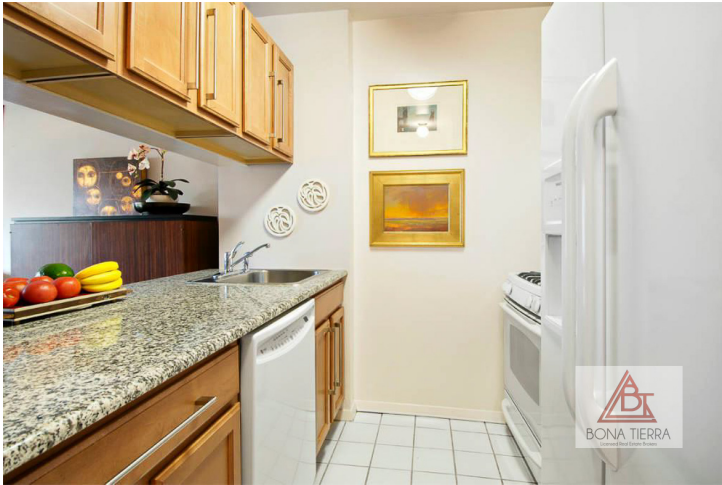
## Floor Plan
